# 2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for this product, based on the product key attributes and the objectives, financial situation and needs of our members that it has been designed to meet.

This product has been designed for consumers whose likely objectives, financial situation and needs (as listed below) are aligned with the product (including the key attributes). This product is for our members who:

o This product is suitable for current or retired employees who are members of an Australian Police Force or Police organisation uniformed or civilian aiming to refinance, purchase and or construct residential property used or intended to be used for investment purposes; and who require at present an interest only mortgage loan to fulfil the desired outcome

## Product description and key attributes

The key eligibility requirements are:

- o Current or Retired employees who are members of an Australian Police Force or Police organisation uniformed or civilian
- o An existing, or becoming a member of Police Bank
- o Be a permanent resident of Australia and 18 years of age or over
- o A minimum 10% deposit
- o Must meet the Bank's Credit criteria

The key product attributes of this product are:

- o Minimum loan amount is \$50,000
- o No monthly account keeping fee
- No annual fee
- o Redraw facility available
- o Repayment frequency options Monthly
- o LVR up to 90% available with Lender's Mortgage Insurance applicable for LVR's over 80%
- o Available for construction purposes

### Variable rate - key attributes:

- o Unlimited additional repayments
- o Interest Only repayments available (Maximum 5 year term)
- o Can switch to Principal and Interest repayment option at any time for Variable loans

#### Fixed rate - key attributes

- o 1-, 2-, 3- and 5-Year Fixed term
- o Up to \$9,999 in additional repayments per calendar year of the fixed term
- Can switch to Principal and Interest repayment option for Fixed Loans at the end of the term

#### Fixed and Variable key attributes

 Customers can get the best of both worlds and get the benefit of having both a variable or fixed loan, by splitting their loan amount

### Objectives, financial situation, and needs

This product has been designed for individuals who:

- o Are Residential Investors looking to make Interest Only repayments and are generally those who are looking for Capital growth vs Equity growth and/or are looking to expand their investment portfolio sustaining a successful retirement plan.
- Have set objectives when considering an investment property purchase with repayments set to Interest Only, this
  repayment option enables the customer to increase cash flow, expand their investment portfolio and/ or maximise
  any potential tax benefits.
- o Have a minimum of 10% deposit to contribute towards their purchase, accepting Lenders Mortgage Insurance will be applicable above 80% and capitalized onto the base loan amount.
- o Looking to reduce repayments by refinancing from another financial institution.
- o Aiming to achieve financial goals relating to residential property investment by expanding their portfolio/ or restructuring their current portfolio to meet their needs.
- Looking for slightly higher risk strategy by relying on Capital Growth vs increasing equity in the property

### Fixed Rate

- Certainty around repayment
- Ability to reduce other liabilities whilst on Interest Only repayment for a fixed term using surplus cash
- o Redraw access allowed for any additional repayments made to the loan whilst on a fixed period

#### Variable

o Flexibility to make unlimited additional repayments and access the additional funds at any time

### Consistency between target market and the product

This product is likely to be consistent with the likely objectives, financial situation and needs of the class of customers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of customers.

This product enables Investors to take advantage of the flexibility of the product whilst making Interest Only repayments. These options include flexible repayment options, through the choice of variable rate, fixed rate, or a split between both options.

The **Variable rate** option offers additional flexibility by allowing additional repayments to be made. This rate isn't locked in, so it is suitable for those wanting to sell their investment property soon, those who aren't sure what the short-term future holds, or those wanting to take advantage of any rate decreases over the loan's term (as this interest rate may change over time). This option also helps to improve cash flow, as members can redraw on any extra repayments made to the loan.

The **Fixed rate** options provide certainty, as borrowers know their repayments won't change during the fixed rate term. Will not be impacted by interest rate fluctuations during the fixed term, however there is limited flexibility, as additional repayments are limited during the fixed term period.

#### Excluded class of consumers

This product has not been designed for individuals who:

- Have a deposit of less than 10%
- Are not Members of Police Bank
- o Do not meet the Bank's Credit criteria at time of application
- o Seeking a home loan for owner occupied property

# 3. How this product is to be distributed

### Distribution conditions

This product can only be distributed and/or in accordance with the relevant product terms and conditions as outlined in the FSG and other relevant material (as amended from time to time). This product is designed to be distributed through:

- o Online through the Bank's Website
- o In-store retail branch network
- o Relationship Banking Team

This product should only be distributed under the following circumstances:

- o An existing, or becoming a member of Police Bank
- o Be 18 years of age or over and meet our Credit criteria
- Access the product though the appropriate distribution channels

## Adequacy of distribution conditions and restrictions

The Bank's application process has been tailored to identify the Target Market described in this TMD as part of the eligibility criteria for the product covered by this TMD, and the use of the Bank's application process would make it more likely that a product covered by this TMD will be acquired by persons in the Target Market.

Significant dealings	The nature and the circumstances of the significant dealing (including why the dealings occurred outside the Target Market), the date range of when the significant dealing occurred, the number of consumers to whom the report relates and whether consumer harm or detriment has or likely occurred as a result of the significant dealing.  The Bank will report if they become aware of a significant dealing in relation to this TMD within 10 business days.
